

### EVERYTHING YOU NEED TO KNOW ABOUT BENEFIT IN KIND

#### COMPANY CAR TAX BANDS - BIK RATES 2015-2020; HMRC zero-emissions cars

Company cars are often essential for business critical operations and make great incentives for attracting top quality staff. They are also taxable benefits, in addition to an employees or directors monthly salary.

Company car tax is known as Benefit in Kind, which is based on how harmful it is to the environment. Every car has a BIK tax banding based on the vehicles  $CO_2$  emissions, and the amount of company car tax you will pay depends on the car's official list price and your annual salary.

#### HOW TO CALCULATE COMPANY CAR TAX

The company car tax payable by an employee is based on:

- 1. The P11D value of the vehicle:
- 2. Multiplied by the car's company car tax rate (dependent on the vehicles  $CO_2$  emissions and fuel type) -this gives you the BIK amount.:
- 3. Multiplied by your personal tax rate, according to your salary (basic rate of 20% or higher amount of 40%).

HMRC offer a Company Car Tax Calculator to make working out BIK easier. You can also see the car tax bands elsewhere in this document.
